1. THE PROJECT

1.1. DESCRIPTION

1.1.1. <u>Title</u>

Educational campaign for youth European students to raise awareness on refugee issues- 2006

1.1.2. Requested funds

EUR 17.110, that is, 66 % of the total cost of the project being estimated in EUR 26.010

1.1.3. Summary of the project

This project aims to create:

An educational campaign to raise awareness among the youth European society on refugees and refugee issues.

This campaign will create and distribute among primary, secondary school and university students as well as among civil society organisations a booklet course created by RESPECT Refugees named "Refugees and Exile".

The booklet will be distributed by RESPECT and participating organisations as well as by teachers from RESPECT's network of schools.

Educational centres, NGOs, Civil Society Organisations and other institutions will be also targeted in a big number of countries in Europe.

The course is to be created originally in English and is to be translated into French, Spanish, Greek, Romanian, Italian, Serbian, Albanian, Turkish, Bulgarian and Azeri.

1.1.4. Goals of the project

Main goal

- Make European youth and adolescents be aware of the problems related to refugees in the world.
- Increase the knowledge civil society has about refugees including NGOs that do work to help and improve their living conditions.

Specific goals

- Show to students from primary and secondary schools general information about what means being a refugee, why there are refugees, problems, solutions, etc.
- Prepare and give to teachers a booklet course that can be explained to students in different ways (conferences, lectures, group chats, etc)
- Encourage students to become part of the pen pal network of students exchanging letters with refugee students mainly from African schools, so they can learn from each other cultures and points of views.
- Encourage classes as a whole to "partner" with a refugee school, so they can take actions on their own to help their sister school (gather schooling material, books, etc to be sent to the refugee schools).
- Spread the knowledge about refugees among NGOs and Civil Society organisations in Europe, focusing in the knowledge of international humanitarian law, migration law and refugees rights.

1.1.5. Justification

Identification of the needs and constraints noticed in the target countries

The RESPECT's network of schools and teachers participating in our different programs have made notice of the lack of information and the total absence of lectures in the regular studying plans for primary and secondary kids about the problems and issues related to refugees in the world.

Most students are not aware that other youth from their same age may have a complete different life, without having in any way the same opportunities and chances to carry on with a normal life. No educational system does cover those topics and therefore RESPECT wants to fill the gap by introducing short courses and information booklets on the subject.

Reasons to motivate the election of the targeted countries and the activities

We have decided to start this campaign in countries mentioned above for the following reasons:

- All countries do have an important population of refugees and / or do have a strong relationship with countries where the refugee population is specially important (i.e. DRC, Western Sahara, Balkans area, Caucasus zone, etc)
- We can target a wide range of beneficiaries thanks to the support and collaboration of our partner organisations which will contribute to the production of the course and the materials in different languages and its distribution among schools and organisations.

1.1.6. <u>Detailed description of the activities</u>

a) Design and preparation of the materials for the educational campaign

a. Number of booklets and type

- "Refugees and Exile": aprox 8000 booklets, 30 pages book, A4 colour

b. Content description

The course will include the following topics:

- ABOUT REFUGEES AND IDPS
- REFUGEES & EXILES: HISTORICAL PERSPECTIVES
- CAUSES OF CONFLICT AND POPULATION DISPLACEMENT
- PSYCHOLOGICAL CARE AND PSYCHOSOCIAL INTERVENTIONS
- GLOBALIZATION AND FORCED MIGRATION
- REPATRIATION AND POST-CONFLICT RECONSTRUCTION
- REFUGEES & EXILES: CASE STUDIES
- LIVING IN A REFUGEE CAMP

c. Working methods and revisions

The course will be prepared by RESPECT volunteer staff, being most of them teachers and professionals with long experience in the topic. Work is done mainly online and split in groups, being one person responsible for a module. Feedback is gathered from the whole team after each module has been completely drafted.

A Word version will be created in English and distributed to RESPECT participating project partners for translation.

d. Layout and final design

RESPECT will create the final layout and graphical images for each one of the versions in the different languages.

2.1. Expected result and impact on beneficiaries

RESPECT expects to:

- 1. Increase the awareness among students and youth in general about the problems refugees do face
- 2. Teach them about a different way of living
- 3. Convince students to join the pen pal letter exchange so they can write directly to a refugee student.
- 4. Convince schools as a whole to partner with a refugee school so they can provide some direct help.

RESPECT believes the sensibilization of youth on those subjects will bring very positive effects during a whole life. It will open their minds and will provide new cultural points of view, will promote tolerance and friendship among different cultures.

RESPECT wants also to increase the network of schools participating in its programs and the number of letter exchanges between refugees and non-refugees.

RESPECT and its partners will publish on its website the course to be created and it will be possible to download it in PDF format so anyone interested can have it.

2.3. Multiplication effects. Short and long term results

According to the result of this campaign, RESPECT will:

- Translate the course and materials to more languages
- Expand the educational campaign to other countries.
- In a long term vision (3-4 years) RESPECT plans to have covered an increasing number of primary and secondary schools in as many schools and youth organisations as possible.

- RESPECT wants to partner as many non-refugee students with refugee ones in as many countries as possible.

4.1.2. <u>Description</u>

4.1.2.1. Creation date

RESPECT Refugees is a Belgian ASBL committed to raising awareness among international youth about refugees and refugee issues, encouraging activism among youth, and further empowering refugee children and communities through letter and cultural exchange, through the donation and transport of education-related material aid.

It was born when a few volunteers from RESPECT International, a Canadian-based organisation, decided to start carrying on RESPECT International's activities also from Europe, under a completely separated organisation (from legally and financially point of view) but following the same principles, sharing the same brand and

collaborating together for the benefit of those most in need. RESPECT Refugees Europe established its headquarters in Brussels in May 2005 and started building the core infrastructure needed to execute its projects.

4.1.2.2. Statement of purpose

RESPECT is committed to raising awareness among international youth about refugees and refugee issues, encouraging activism among youth and further empowering refugee children and communities through letter and cultural exchange, through the donation and transport of education-related material aid.

RESPECT has three main goals:

- 1. To build awareness of refugee issues among youth around the world.
- 2. To connect international youth to refugee youth by pen friend letter exchange.
- 3. To encourage young people to organize events to teach others about refugee issues and to raise funds for their refugee school

4.1.2.3. Main activities

Computers for Refugees

Kids in many countries do not have access to computers, and especially refugees living in difficult conditions, where schooling is also difficult neither do have the facilities to buy them. RESPECT puts in practice a program aimed to set up computer centers in those countries where needs are more crucial. We help children to develop basic computing skills aiming to improve their quality of life. RESPECT signs an agreement of use with the local school or the competent authority. All serial numbers are stored in a database with its destination, delivery date and school responsible. We do conduct evaluation visits to the schools to check whether the computers are still in place and are being used for educational purposes.

Letter Exchange Program

Our number one project is to introduce refugee and non-refugee students through our pen-pal letter exchange program. We receive letters from refugee students which we then forward to a non-refugee school. The students then reply to the letters, and new friendships are born.

Through this interaction students not only learn about another culture, but the experience can be used to help teach other subjects including:

- Language arts teaching students how express themselves when they write letters.
- Geography learning about other countries will take on new meaning because the students know some one in 'that part of the world.'

• Math - learning about how much postage is needed to send the letters. We ask non-refugee schools to include 2 or 3 international reply coupons with their replies to help defray the cost of postage

4.1.2.4. RESPECT University

RESPECT University was established to provide post-secondary instruction to refugee students under the guidance of tutors from around the world. We see this as a logical extension of our mission to link refugee and non-refugee schools worldwide.

To accomplish this:

- We use experienced teachers who want to use their knowledge and experience to help teach students in refugee schools.
- Many of our tutors develop their own curriculum on a subject in one of their areas of expertise.
- RESPECT then matches the tutor with a group of students. RESPECT facilitates the initial contact between the tutor and the students, and helps, as needed, to coordinate the learning process.
- Each class normally consists of six students.
- Teaching and learning are carried out by correspondence, using conventional postal mail services, although contact with local coordinators is maintained via email. The tutor sends a series of assignments which the students complete and then return to the teacher for comments and feedback. (Each assignment can take a month or more to be returned to the tutor because of limited postal service to areas occupied by refugees.)

4.1.3. Resources

Human Resources

RESPECT Europe works only with volunteers; they are classified in three categories:

RESPECT Board: The Executive Board and the Area Directors. People donating
its free time and energy but with a clear compromise with RESPECT, taking duties
and responsibilities on a daily basis and being the official representation of
RESPECT.

- RESPECT Volunteers in Brussels: Volunteers who help us from time to time to do specific tasks in our headquarters. They don't have any specific commitment with the organisation, but they donate their free time and energy whenever they want to do so. They can take small roles and duties and participate in any ongoing project (repairing IT equipment, researching info, preparing packages, updating databases, etc).
- United Nations Online Volunteers: More than half of the work of RESPECT is done online (research, find grants and apply for them, prepare PR materials, write reports, prepare presentations, etc). RESPECT is registered and partner of ONV where we post our assignments. Normally, about 20 online volunteers are enrolled permanently in our different activities.

Financial Resources

RESPECT is supported primarily from private donations of individuals willing to contribute to our projects. Another source comes from the member quotas and sporadic actions like T-shirt selling or fundraising parties in Brussels.

RESPECT's fundraising team is working to contact companies, foundations, international organisations and other sources of funding in order to create a strong network of support to achieve more ambitious programs.
